Under Article 12 of the Thoroughbred Breeders' Association Ltd. two elected Board Members complete their current terms of office on the Board this year, namely Tom Blain and Ted Voute.

Under Article 17.1.1 two Board Members will be elected by postal/email ballot in accordance with Article 28. Any TBA Member who wishes to put themselves forward as a potential candidate for the Board elections should in the first instance write to the CEO (the form enclosed is provided for this purpose) confirming their request to be considered as a candidate and provide six signatures of support from current TBA Members; the signatories can offer their support to only two candidates in any one year.

Candidates also need to supply a head and shoulders photograph of themselves plus a profile which, for those candidates going forward to the Election, will be published in August. The Ballot Forms together with the profiles of all candidates will be sent to TBA Members in early August. Profiles should be no longer than 200 words in total and be composed under the following three headings: Career/Profession; Breeding/Racing Interests; Profile.
